## VILLAGE OF RIDGEWOOD DEPARTMENT OF PARKS AND RECREATION SKATEPARK RULES AND REGULATIONS

## Ordinance No. 3638, 3639

- 1. The Village of Ridgewood temporary Skate Park facility, located adjacent to the Stable, 259 N. Maple Avenue, will be available annually, after the close of the hockey season, from mid-April through mid-October, for use daily from 9 am to sunset daily. No loitering after the facility is closed.
- 2. Use is limited to skateboards and in-line skates. <u>Bicycles, roller skates, go-peds, scooters, and any other</u> motorized vehicles are prohibited.
- 3. The Skate Park is a "skate at your own risk, non-supervised facility". Skaters should inspect skating surfaces before use and remove all trash, debris and objects that may prevent a smooth safe riding experience. Damage should be reported to the Village of Ridgewood Parks and Recreation Department at the Stable, 259 N. Maple Avenue, Ridgewood, NJ.
- 4. Protective equipment is required at all times (helmet, elbow, wrist and knee pads and protectors).
- 5. This park has been designed for beginner to intermediate skill levels. Be courteous to others using the facility and other park patrons. Parental supervision is strongly recommended for participants under the age of 18.
- 6. Skating or riding when wet, raining, snowing, or during Skate Park maintenance periods is not permitted.
- 7. Skating during scheduled use for Parks and Recreation instructional programs is not permitted.
- 8. Food, drink, smoking, alcoholic beverages or controlled substances are prohibited.
- 9. No alcoholic beverages are or will be permitted in the building or on adjacent Village of Ridgewood property for any meeting or function.
- 10. No smoking is permitted within the Skate Park or the surrounding parklands.
- 11. Use of profane, loud, threatening, indecent language is prohibited. No loud music.
- 12. No pets allowed.
- 13. Membership Badge Required: It shall be unlawful for any person to use the seasonal Skate Park facility or to enter upon its grounds thereof during the afore described season without having first obtained a photo-identification Membership Badge provided for such. The Membership Badge shall be carried and exhibited by the person to whom it is issued at all times while at the seasonal Skate Park or its grounds and is part of the user accountability for the facility. The membership badge process includes a hold harmless waiver to be executed by the badge holder or parent/guardian if under 18.
- 14. Organized groups of 10 or more require a permit from the Department of Parks and Recreation. All members of the group shall have membership badges in their possession.
- 15. Skate Park users shall not park a motor vehicle in the parking lot of Lester Stable (NJS 39:4-56.6). Parking at the Stable, 259 N. Maple Avenue, Ridgewood, is for Stable business only. Parking for the Skate Park facility is at Graydon Pool (corner of Linwood Avenue and Northern Parkway).
